

What is BEARR?

The BEARR Trust is a UK-based organisation set up to help children and other vulnerable and disadvantaged groups in Russia, Eastern Europe, Central Asia and the South Caucasus. We believe the best way to do this is to help small health and welfare non-governmental organisations in the region to build knowledge, know-how, skills and contacts, including with those doing similar work in the UK.

BEARR works with partners in:

Russia, Ukraine, Belarus, Moldova, Georgia, Armenia, Azerbaijan, Kazakhstan, Kyrgyzstan, Tajikistan, Turkmenistan, Uzbekistan.



BEARR's priorities

- To work with smaller organisations committed to reform in the health and social sectors
- To facilitate networking and exchange of information
- To encourage sharing of experience and learning
- To help organisations working in the region to identify potential partners
- To provide seed funding to assist selected organisations to launch or extend partnerships
- To lobby, and seek wider support, for the role of smaller organisations.

BEARR's activities

The BEARR Trust inaugurated a Small Grants Scheme in 2006 to provide seed-corn funding for small NGOs working in partnerships in the field of health and social welfare. The Small Grants Scheme focuses each year on specific areas including young people, homelessness and vulnerable groups. Most funds donated to BEARR are used for these grants.

Annual Conference
